

DIRECTIVE 2004/38/EC

Family members of an EU citizen,

himself or herself covered by the application of Directive 2004/38/EC - VISA C

This information is also intended for family members of a national of the European Economic Area and family members of a Belgian who returns to Belgium after having legally resided for more than 3 months in another state of the Union.

The family member of a Union citizen who applies for an entry visa, applies by referring to Directive 2004/38/EC on the visa application form.

Supporting documents to present:

- A file of original documents in the order of the list below;
- A file of copies of the same documents, in the same order.

For your information:

- 1. The <u>underlined text</u> in the list are **links** containing detailed explanations. The **texts in bold** concern a **point of attention**.
- 2. Kenyan official documents and their translation must be legalized. Official documents of non-Kenyan residents, drawn up in their country of origin; consult the website of the relevant Belgian Embassy or Consulate.
- 3. The original documents will be returned to you at the end of the procedure together with your passport.
- 1) Passport valid for at least 12 months and showing at least 2 unused pages. (the 2 copies of the files must include a copy of the passport).
- 2) 2 visa application forms, duly completed, signed and dated.
- 3) 2 recent passport photos.
- 4) Copy of Kenyan National Identity Card OR Residence Card (if non-Kenyan applicant)
- 5) A copy of the identity card or passport of the Union citizen.

- 6) Proof that the EU citizen exercises his right to free movement and is therefore himself covered by Directive 2004/38/EC:
 - Proof that the EU citizen is moving to Belgium, OR
 - Proof that the EU citizen already resides in Belgium, OR
 - Proof that the Union citizen is a Belgian who returns to Belgium after having resided legally for more than 3 months in another State of the Union
- 7) Proof that the applicant is traveling with, or joining, that EU citizen.
- 8) Either **proof that the applicant is a close family member** of the Union citizen by civil status certificates or equivalent. These close family members are detailed in <u>article 40-bis</u> of the law of 15/12/1980:
 - The spouse, the registered legal partner and the children of a spouse of the couple under the age of 21;
 - Dependent children of a spouse of the couple who exercises the right of custody (in the event of shared custody, the official agreement of the other parent is required);
 - The parents of a minor EU citizen under their care, of whom they officially have custody rights;
 - Dependent parents of a spouse of the couple.

Or, **proof that the applicant is a distant family member** of the Union citizen by acts of civil status or equivalent. These distant family members are detailed in <u>article 47/1 of the law</u> of 15/12/1980:

- The partner with whom the Union citizen has a duly attested lasting relationship (de facto partnership);
- Family members who, in the country of origin, are dependent on or form part of the household of the Union citizen;
- Family members for whom the Union citizen must imperatively and personally take care because of serious health problems.
- 9) If you are dependent on a Union citizen or you have a Union citizen in your care: proof of financial support and absence of own sufficient means of subsistence for at least 6 months before the submission of the visa application - if applicable - either from yourself or from the Union citizen.
- 10) If you depend on the Union citizen for your care of a serious health problem: a medical certificate confirming the existence of this serious health problem and a document explaining the reason why the Union citizen must imperatively and personally take care of you.

Only submit legalized/apostilled and translated official documents.

In exceptional cases, additional documents may be requested by the Embassy, even documents not listed at all.
